INTRODUCTION TO THE COURSE

The goal of this course is to offer an in-depth introduction to a fundamental geostrategic area since the end of World War II, that is, the Middle East. The course will cover region by region but always trying to keep the global picture behind the specific region.

The title of this course makes reference to both, Carter Doctrine (1980) and George W. Bush's Greater Middle East and North Africa Initiative (2004), by which the Middle East region is studied with North Africa, the Horn of Africa and Central Asia, covering the Area of Influence of the Central Command.

30% Presentations

Students will give a presentation in groups of five or six. They will use the time of one session to explain to their classmates the things they consider important in a presentation given by the professor. The reading will be provided for the professor and the topics covered by the text will not be explained in class, so students need to teach a full session.

At the end of the presentations it'd be good to come up with questions for the audience or allow them to ask questions since the topics presented will be part of the final exam.



10% Final Exam

This final exam will consist of two questions. Each of these questions will be answered using a specific number of lines given by the professor. The answer needs to be clear and direct, which means that students need to answer the question with "objective" knowledge.

This exam is not an essay, that is, the students is not supposed to create a narrative to answer but to give all the information covered in class.
