### Course Description

During the course, students will cover the following areas of study:

1. Inchoate/Anticipatory Offences: Incitement, Conspiracy, Attempt
2. Homicide. Murder, Manslaughter (Voluntary and Involuntary)
3. Non-Fatal Offences Against the Person. Assault and Battery, Aggravated Assaults: (Assault with intent to resist arrest (assault on, resistance to, or obstruction of constables), Assault occasioning actual bodily harm
4. Offences Against Property: Theft, Robbery, Obtaining property by deception, Temporary deprivation, Blackmail, Criminal Damage, Burglary

### Course Aims and Objectives

This course aims to acquaint students with the principles and criteria upon which a person's responsibility under criminal law will be assessed. This requires an analysis of the nature of criminal offences, the elements of a crime, parties to crime and an appreciation of the circumstances in which people are absolved of responsibility under the criminal law. Having studied these basic principles, the course then aims to enable students to acquire a knowledge and appreciation of particular inchoate offences against the person and offences against property.

### Teaching Methods

The course is delivered through a mixture of lectures, discussions, presentations, and problem-solving activities.

### Course Teaching Hours

42 hours (30 hours of lectures, 12 hours of seminars/tutorials and student-led presentation/seminars). The course is delivered during the Spring semester in 14 weeks (3 hours/week).
