Course Description

- 1. Ethnicity, Culture and Law (Introduction). Migrants and old minorities in the UK, Cyprus and Europe; cultural identity; pluralism and its limits; universalism and cultural relativism in the law; public private domains; tolerance and human rights.
- 2. Developments in English law; judicial stances on cultural diversity; legislation, European and international instruments on cultural rights and human rights; policy options.
- 3. Case studies: Jews, Gypsies and Muslims in the UK.
- 4. Cyprus Constitution and the rights of communities and religious groups; Inter-communal strife and dealing with diversity; lessons from British experience; European and international instruments
- 5. Case studies: the two Communities and religious groups; migrants and minorities in Cyprus

Course Aims and Objectives

The course aims to examine an analysis of the interaction between cultural traditions of ethnic groups in a state to the law drawing on the way English law approaches British ethnic minorities and comparing that to the way the Cyprus Constitution treats communities and religious groups.

The course explores the guiding principles and policies which should govern the legal responses to ethnic diversity and tests them by references to case studies, with reference to the increasing body human rights law concerning the cultural rights of ethnic minorities. The development of English Law in response to the cultural, religious and ethnic concerns of minorities, the global resurgence of 'ethnic' concerns and the rise of racism, the process of European integration and increasing influence of human and minority rights are developments that push in different directs and make policy making difficult. Hence the need to explore different legal responses.

Teaching Methods

The course is delivered through a mixture of lectures, discussions, presentations, and problem-solving activities.

Course Teaching Hours

42 hours (30 hours of lectures, 12 hours of seminars/tutorials and student-led presentation/seminars). The course is delivered during the Spring semester in 14 weeks (3 hours/week).
