Course Description

The focus of the course is nursing care of patients of all ages experiencing interference with psychosocial functioning and psychiatric illness. The course emphasizes the development of critical thinking, through holistic and humanistic approaches. It teaches the student to develop appropriate nursing competencies and total management of patient care through the use of the nursing process with emphasis on evaluation. The course format is 5h/week lectures/conferencing and 2.2h/week student engagement in professional learning activities.

To gain practical experience the student will be allocated in a clinical area that cares for mentally ill patients.

Topic Areas

- 1. Foundations of Psychiatric/mental health nursing
- 2. Student issues related to clients and the environment
- 3. Theoretical perspectives, legal/ethical issues, cultural issues.
- 4. Anxiety and related illnesses
- 5. Mood disorders: Depression and mania, schizophrenias.
- 6. Personality disorders; substance related disorders
- 7. Delirium, dementia
- 8. Cognitive disorders; sexual disorders; adjustment disorders
- 9. Eating disorders, Childhood and adolescence disorders.
- 10. Therapeutic modalities: crisis intervention
- 11. Interactive therapies and method of implementation
- 12. Psychopharmacology and other therapies
- 13. Survivors of violence/suicide/grief and loss
- 14. Physiologic aspects of mentally ill clients and their implications for the wellbeing of the patient/client.

Conferencing Sessions

During conferencing through student presentations or discussion, the student demonstrates knowledge and skills with specific examples as to how the knowledge from case studies research and epidemiological studies is applied to practice settings in management of care.

- 1. Psychological concepts, human needs, thoughts, feelings and behaviour, stress and anxiety, conflict, frustration and coping
- 2. Psychiatric mental health nursing practice concepts: therapeutic communication, and individual counseling
- 3. Psychosocial assessment and planning of care
- 4. Group dynamics and therapeutic groups
- 5. Stress management
- 6. Crisis theory and intervention
- 7. Biological therapies; Parmacotherapies
- 8. Personality traits, styles and disorders
- 9. Disorders of developmental period (children, adolescence, adults and the elderly)
- 10. Clients with substance -related and eating disorders
- 11. Clients with anxiety, somatoform and dissociative disorders
- 12. Clients with affective disorders, suicide and grief
- 13. Trauma, violence, abuse sexual disorders and impulse control disorders

Research paper: The student can write a 2-3 pages papers (six in total) on a chosen conference topic of the week or a 6-7 page referenced research paper (3 in total).

- 1. Discussion and presentations of case studies from students own clinical experiences in mental health setting
- 2. Using Evidence-based learning approaches the students present their chosen cases and share learning with peers.
- 3. Peer review

Professional Learning Activity (PLA), attendance and documentation. The students have to present at the end of the semester the completed forms of assigned PLA for the semester. The PLA should contain: the title of he activity accomplished, the place and time of the offering, the key points of the activity and description of the application to nursing management.
